ANNEXURE

RULES AND REGULATIONS

The Smile Foundation - Scholarship Programme is voluntary and not a matter of the claim. The beneficiaries enjoy it solely at the will and pleasure of the organization. The scholars' performance will be reviewed periodically.

The Scholarship should not be taken as a guarantee for future studies. Besides the privilege vested in the organization to withdraw the Scholarship, a beneficiary will cease to be a member of the scholarship and will not be entitled to any benefit under the following conditions:

1. If the information at the time of application furnished is found to be false.
2. If the beneficiary or family member misuses/ misappropriates the whole or any part of the aid, for example, spends the amount other than where it should be spent.
3. If in the opinion of the committee, the beneficiary fails in any of the three parameters i.e. Need, Ambition and Talent at the time of periodic evaluation.
4. If the beneficiary is found to be engaged in any activity contrary to the aims and the objectives of the organization. The Scholarship will be over the moment the study is over.
5. If the scholar does not attend the activities designed for them like personality development sessions, exposure visits, meetings, etc. without prior information and permission from the mentor.
6. If the academic scores fall below 60%.
7. If the Trustees decide to discontinue or stop the said scholarship for any beneficiary, or otherwise stop the entire scheme by the resolution of the trustees, the scheme as a whole or in respect of any individual beneficiary shall stand ineffective forthwith.

Over and above, the last decision of continuation of Scholarship will rest with Smile Foundation and Birlasoft management.

The Scholars must abide by the following rules:

1. The scholar would need to be in regular contact with the mentor assigned to her.
2. The scholarship amount must be used only for supporting the tuition fee of the scholar and for each scholarship installment released fee receipts have to be submitted to the organization.
3. The scholar needs to update the mentor about their latest academic marks as soon as they get it.

The scholarship support is subject to the availability of funds and support from the donor and will be awarded for a specific time period which will be intimated to the scholars initially only.
