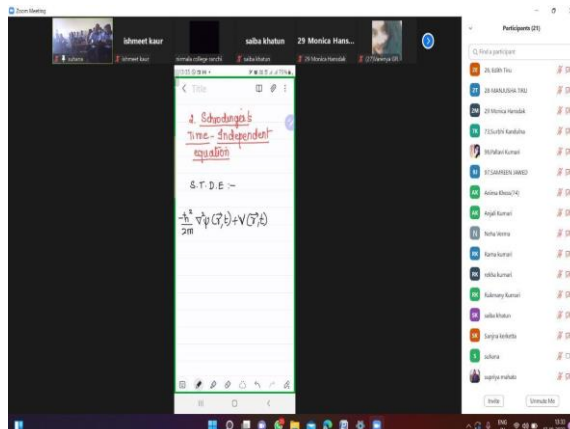
## Report
